Allowances

Allowances	Rate
Expenses reimbursement	reimbursement for work related expenses that are not covered by another allowance in the award
Mobile phone allowance - a mobile phone on plan	reimbursement of at least 50% of the cost of the employee's monthly mobile phone plan (for a maximum monthly phone plan of \$100)
Mobile phone allowance - a pre-paid mobile phone	reimbursement of a reasonable amount agreed to in writing by the employer and employee
Motorcycle allowance	\$0.33 per km up to a maximum of 400 kms per week
Stand-by and call-out allowance - strata / community title management or property management classifications only	a method of payment agreed in writing between the employee and employer for due compensation for the employee being on stand-by and/or call-out
Working away from usual workplace - excess travel time - ordinary hours	payment at the minimum hourly rate for all time reasonably spent travelling in excess of the time normally spent travelling between home and the employer's business or office premises
Working away from usual workplace - excess travel time – overtime	payment at the appropriate overtime rate for all time spent reasonably travelling in excess of the time normally spent travelling between home and the employer's business or office premises

Motor vehicle allowances

Where an employee is required to use their own motor vehicle in the course of their employment or for undertaking excess travel, they can be reimbursed by:

- Payment of a standing charge plus an amount per kilometre travelled in performing their duties, or
- Payment of a lump sum, or
- \$0.98 per kilometre to a maximum of 400km per week
